Eligibility & Approval Criteria

- From appropriate and reputable Organisations/Institutions in Pakistan in line with Novo Nordisk's Triple Bottom Line commitment with the ultimate aim of benefiting patients
- Received with complete documentation through proper channels at least 8-12 weeks before the activity

Outside of Eligibility Scope
